Pro Tools Certification Courses

In collaboration with Training & Instructional Technology, we are happy to offer Pro Tools 101, 110, and 201 certification courses throughout the year. Whether you are an experienced DAW (Digital Audio Workstation) user who wants to dive headfirst into Pro Tools, or an existing user simply wanting to improve your skills and credentials, our standard and accelerated course options will get you to where you want to be. Each course concludes with participants taking the official Pro Tools certification exam for that level. Please note, faculty are not compensated for participating in Pro Tools certification courses.

INCLUSIVE TEACHING AND LEARNING

ETUDE Faculty Scholars

Enhancing Teaching through an Understanding of Diversity and Equity

Berklee students arrive on campus bringing with them a variety of skills, different levels of academic and musical preparation, and a broad range of expectations and experiences. Often without knowing it or meaning to, we can behave in ways that dissuade our students from feeling that they belong to our community, implicitly privileging the learning of some students over others. Through workshops, consultations, and the Equity Partners Program, ETUDE seeks to engage faculty in taking a leadership role in supporting their colleagues' efforts to both challenge students to learn while demonstrating empathy, and a sensitivity to each student's individuality, history, and future. This faculty team offers structured opportunities for their colleagues to learn more about pedagogical strategies, course content, and campus resources that foster an inclusive community and work to eliminate discrimination and harassment.

Equity Partners Program

The Equity Partners (EP) Program is a new initiative led by the ETUDE Faculty Scholars with support from the Center for Diversity, Equity, and Inclusion, and is open to all faculty and staff at the College and Conservatory. Equity partners volunteer to undergo a series of professional development sessions on equity and on developing the knowledge and skills to ensure that all faculty, staff, and students feel welcome as full members of the Berklee community.

Those interested in becoming an Equity Partner must attend a single, two-hour Equity Partner Foundations Session. During the session, you will engage in dialogue with colleagues on topics and questions central to equity in teaching and learning as well as discuss and unpack terminology and vocabulary fundamental to our understanding of identity, belonging, and civil and human rights. This session is intended to provoke as many questions as it answers with the hope that attendees will want to further explore—and put into practice—pedagogical practices that enhance equity in teaching and learning.

GRANTS AND FUNDING

The Office of Faculty Development is pleased to be able to offer nearly \$200,000 annually in support of faculty projects through various grants and funding opportunities. All active faculty members (part-time and full-time) are eligible to apply. Recipients are selected on a competitive basis by rotating adjudication committees. All grants and fellowships (with the exception of the Travel Grant) are awarded annually and are good for one year. At the end of the award year, each recipient is expected to submit a final report outlining the outcomes of their project.

Faculty Development Travel Grant

Up to \$600 | Open to Boston/Valencia faculty, chairs, and deans | Awarded monthly

The Faculty Development Travel Grant provides modest support (up to \$600) for travel related to professional development opportunities. Open to all faculty, chairs, and deans, applications are accepted and reviewed monthly. Applicants should apply at least 3-4 weeks in advance of travel. Requests for past travel are not eligible.

Faculty Recording Grant

Up to 17 studio hours | Boston faculty only |Awarded annually (spring)

The Berklee Faculty Recording Grant is available annually to Boston-based faculty and provides unique, personal access to Berklee's recording studios, typically available only for student and classroom use. Valencia-based faculty are not eligible to apply for the Boston Recording Grant.

Chair Recording Grant

Up to \$2,500| Boston faculty only |Awarded annually (spring)

The Chair Recording Grant provides reimbursement (up to \$2,500) for expenses related to a recording project.

Faculty Development Grant

Up to \$2,000 | Boston/Valencia faculty |Awarded annually (spring)

The Berklee Faculty Development Grant is awarded on a competitive basis, to faculty engaged in projects of professional development that align with the Office of Faculty Development mission statement.

Berklee Faculty Fellowship

Up to \$7,500 | Berklee Boston/Valencia faculty |Awarded annually (spring)

The Berklee Faculty Fellowship is awarded on a competitive basis to faculty to engage in specific creative endeavors that develop their academic and artistic career, and enhance Berklee's participation in the world of education and/or the arts. Projects may include—but are not limited to—research, performance, study, or composition. Awards are granted based on the quality of the proposal and the scope of the project.

Faculty Led Innovations Grant (FLY)

Up to \$10,000 + \$6,000 stipend | Berklee Boston/Valencia faculty | Awarded annually (spring) FLY—Faculty Led Innovations in Education—is a unique program that provides space and support to select faculty members to engage in creative and academic work that advances the college's strategic plan, improves the student experience in innovative ways, and provides for the development of themselves and their peers. Recipients become part of the extended team of collaborators working in Faculty Development across Berklee, demonstrating excellence and leadership in teaching, performance, composition, practice-based research, and projects in emerging fields.

Newbury Comics Faculty Fellowship

Up to \$65,000 | Berklee Boston/Valencia faculty |Awarded annually (fall)

The Newbury Comics Faculty Fellowship supports Berklee faculty members in designing creative and innovative approaches to fostering student engagement and learning. Projects that seek to transcend traditional boundaries, take risks, and/or explore ideas in new ways are encouraged. Strong proposals may include but are not limited to new learning opportunities, pioneering approaches to course development and teaching, development or training in creative multimedia technology, and advancement of music, music performance, and/or music industry.

RESIDENCIES

Berklee Dance Residency at Jacob's Pillow

Becket, MA| March 2020

The Berklee Dance Residency at Jacob's Pillow is intended to give artists the time and space to research and develop new dance works. Open to all genres, proposed works may be at varying stages of development. The residency includes on-site accommodations for up to seven people and exclusive use of the newly constructed Perles Family Studio.

Chalk Hill Artist Residency

Healdsburg, CA | May 2020

The Chalk Hill Residency is devoted to supporting artists of all types by providing space and time on the Warnecke Ranch to pursue creative projects. The concept for the residency is based on the vision of the late John C. Warnecke, to provide a space for artists to live and work together. Settled next to the Russian River in Alexander Valley appellation, the Warnecke

property also boasts 80 acres of award-winning vineyards providing visitors with a backdrop truly unique to Northern California.

Hearstudios Recording Residency

Hearstudios is the dream child of Berklee alumnus, Jason Hearst. Located in the peaceful harbor village of Camden, Maine, the studio is outfitted with state-of-the-art gear and a comprehensive array of desirable new and vintage electronic and acoustic instruments. Jason's goal is to provide a pristine recording experience within a creative space that is warm, welcoming, and efficient. Accommodations for this residency can comfortably house one group of up to eight people and provides six days of dedicated studio time, on-site lodging, and participant stipends for meal and travel expenses.

Guilford Sound Recording Residency

Guilford Sound is a newly constructed recording facility located in the foothills of the Green Mountains in Guilford, Vermont. With this one-studio, energy-efficient site, owners Dave Snyder and Sara Coffey have dedicated themselves to providing artists a serene environment to create new work. Guilford Sound can accommodate one group of up to ten people and provides six days of dedicated studio time, on-site lodging, and participant stipends for meal and travel expenses.
