Description: This course is required of all fifth semester Performance majors and taken in conjunction with ILRE 375 “Recital Workshop for Performance Majors.” Preparation of repertoire for performances in the “Recital Workshop” is included. Recital preparation instruction provides students with individual guidance in developing performance technique, learning repertoire, and strengthening their sense of musical direction in building a performance. The content of “Recital Preparation” material is established by each instrumental department; supplementary material may be developed by individual instructors. Performance majors who play more than one instrument proficiently may declare a secondary instrument. This course supports the Secondary Instrument Program.

Course Objective: The general goals of “Recital Preparation” lessons are stated above in the course description. Upon satisfactory completion of this course, you will have progressed, with the guidance of your instructor and with effective individual practice, toward greater mastery of the techniques, skills, and musical/artistic concerns which are vital to professionally viable performance on your principal instrument. Your instructor will help you select and prepare repertoire for the performances required in ILRE 375 “Recital Workshop for Performance Majors.”

Required Materials: None. Your instructor may provide supplementary materials in the form of handouts.

Coursework & Out-of-class Preparation: Included in your weekly lesson period will be assignments in performance technique, repertoire, and concept-assimilation. Your fulfillment of these assignments will be closely monitored, and your success in realizing your potential as a performer will depend largely on the diligent maintenance of a well-planned practice schedule. While individual requirements vary widely, it is generally agreed that in order to maintain satisfactory progress in this study, ten to fifteen hours per week of individual practice, distributed on a daily basis, are necessary.

Determination: Your final grade will be determined by considering the following components at the indicated weights:

- 50% Preparation for required performances (ILRE 375)
